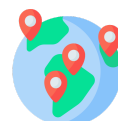

- **Return Ticket:** Evidence of your onward or return travel.
- **Financial Stability:** Documents showing you've got enough funds for your stay.
- **Health Insurance:** Valid coverage that protects you during your time in Bahrain.

2. **Visit the Portal:** Head over to the eVisa website and select "[Bahrain eVisa Application Form](#)"

- FDI flow growth rate has been **5–7%** annually (approx.).

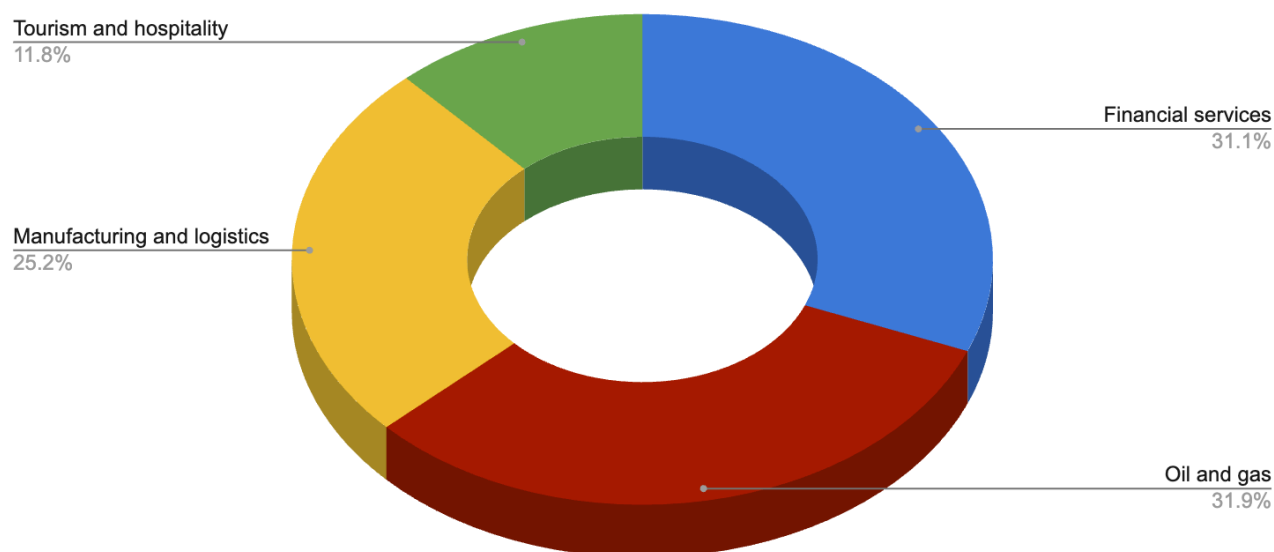


## Ease of Doing Business

## Quick FAQ

- **What is the Bahrain Business eVisa?**  
It's an electronic visa for business travel—perfect for meetings and negotiations, but not for paid employment.
- **What docs do I need?**

A valid passport, accommodation proof, invitation letter, return ticket, financial proof, and health insurance.

- **How long is it valid?**

Typically 14 or 30 days, depending on the visa type.

- **Can GCC residents apply?**

Yes, with some relaxed requirements.

- **What if my eVisa is denied?**

Don't sweat it—ask for clarification, add any missing docs, and reapply.
